

Frequently Asked Questions

What courses do I need to complete in order to graduate?

To be eligible to graduate, you must complete 20.0 credits including:

- 16.5 core Community Social Services credits
- 2.0 CSS restricted electives (4 courses)
- 1.5 general elective credits (3 courses)

What electives should I take?

Choose electives from the published Electives Course Schedule that interest you. Electives offered in the fall may differ from electives offered in the winter semester. An 'Electives' course schedule will be available before course selection. If you are interested in applying to graduate program(s) after graduation, you may wish to tailor your electives to meet the admission requirements of various programs.

May I take a CSS course as an elective?

No. Electives are designed to give students breadth in their studies and provide an opportunity for CSS students to take courses with other Guelph-Humber students. You must take courses from the Electives Course Schedule.

Am I required to take my electives at Guelph-Humber?

Letters of Permission may be available in order for you to take electives at another university. Please see your Academic Advisor.

I am a transfer student; how do I know which courses to select?

Transfer Students should use this document in conjunction with their Official Transfer Credit Assessment to determine which courses they have been granted, and which courses they need to take. Transfer students should meet with their Academic Advisor to confirm the schedule they have developed in advance of the course selection dates.

Are there Field Placements in the CSS Program?

Yes. Starting in second year, students receive workplace experience through three progressive practicum placements in social service agencies across the GTA. Students will be considered "professionals in training" and performance expectations will increase according to the semester level. Throughout the placements students participate in classroom seminars to critically analyze and share their experiences.

Am I required to complete an Area of Emphasis?

Completing an Area of Emphasis is optional. To complete an area of emphasis, students are required to complete at least 1.5 restricted electives within a specific area [*Mental Health and Addictions (MHA)* OR *Youth and Families (YF)*]. Students will be required to submit a [Declaration of Area of Emphasis form](#) online no later than the 7th semester of study.

Area of Emphasis Courses/ Restricted CSS Electives

Students may choose between two optional areas of emphasis. To obtain recognition for an area of emphasis, students are required to complete a **minimum of 1.5 restricted elective credits (3 courses)** from the listing in that specific area. Only one area of emphasis may be declared.

If opting to complete an area of emphasis, students must declare an area of emphasis by the start of their seventh (7th) semester of full-time study. Only one area of emphasis may be declared. Transfer students admitted under an articulation agreement (block credit) are not eligible for an area of emphasis.
