

IGNITE Bursary

The IGNITE Student Union has designated a portion of its budget to assist students who have a proven financial need. This bursary will assist students who are experiencing hardship due to their financial situation. This bursary is only a supplement and is meant to relieve a student's immediate and temporary need.

TO QUALIFY FOR THE IGNITE BURSARY, APPLICANTS MUST:

- ☑ Be enrolled in a full-time course load (i.e. 2.0 credits or more) and paying full-time tuition
- ☑ Be a Canadian citizen, permanent resident, a protected person or International student.
- ☑ Have proven financial need (you may be asked to provide proof of expenses before any decision can be made)
- ☑ Have not received a student financial aid bursary this semester
- $\ensuremath{\square}$ Have demonstrated a commitment to their program of study

The PROCESS:

- ☑ Bursaries are awarded on an individual basis upon consideration of expenses, income, family support, part-time employment opportunities, and personal circumstances.
- ☑ Student Financial Services will review applications in date order received on a weekly basis until funding is exhausted.

- ☑ Complete this application form.
- ☑ Be sure to provide your SIN as it is required for successful applicants to receive their funding
